

**Information on the processing of personal data in
the context of the use of photo and film recordings
Art. 13 GDPR (General Data Protection Regulations)**

Purposes of the processing:	<ul style="list-style-type: none"> • eMag articles and/or other publications on Infineon's intranet • Publication on Infineon websites • Publications on corporate events of Infineon
Legal Basis for the processing:	The creation, publication and use of the photographs and films shall be based on the consent (Article 6 par. 1 lit. a) GDPR) of the person photographed and/or filmed (also referred to as the Data Subject).
Recipients / Categories of recipients of the personal data:	Recipients of photo and film recordings can be other group companies (e.g. for intranet publications) or external service providers who create electronic media for Infineon, such as websites, brochures or other printed matter.
Transfer of personal data (photo and/or film) to a third country:	Transfer is planned only within the Group, primarily for internal Group reports on the Intranet. A data processing agreement has been concluded for transmission between the companies of the Infineon Group which has been audited by the Data Protection Supervisory Authorities.
Period of storage of the personal data (photo and/or film):	Publications serve the internal and external presentation of the company and its employees. Publications also serve as a reminder or source of information and can be stored indefinitely.
Right of the Data Subject:	As Data Subject, you have the following rights according to the GDPR: <ul style="list-style-type: none"> • Right of Access (Art. 15) • Right of Rectification (Art. 16) • Right of Erasure (Art. 17) => "Right to be forgotten" • Right of Restriction of Processing (Art. 18) • Right to Object (Art. 21) • Right of Data Portability (Art. 20)
Right of Revoke of the Consent:	You can revoke your consent at any time with effect for the future (Art. 7 par. 3 GDPR). Please address your revocation to the Controller or the Data Protection Officer.
The right of lodge a complaint with a supervisory authority	If you are of the opinion that the processing of your personal data (including photo and film shots) violates data protection laws, you have the right to complain to a Data Protection Supervisory Authority. Is the provision of personal data mandatory or necessary?	The provision or creation and publication of photographs and film footage is NOT required by law or contract or required for the conclusion of a contract. A provision or consent to the creation and publication of photographs and film is voluntary. No giving or a revoke of your consent will not have any negative consequences or repercussions for you.
